Waste management is a common practice across society; monitoring and paying attention to the volume of waste generated within households, businesses, and public areas has become a hot topic as the longlasting impact of waste on landfills has become more and more of a concern. Modernday responsible recycling and recovery is a key focus at SMI, following our adopted approach to waste as we are committed to a zero-tolandfill approach to our waste.

SMI's waste can be broken down into the waste either of our sites generates, and we are looking at how our customers dispose of our products once they reach the end of their life cycle.



#### SMI's Waste:

- The head office generates General waste (Mixed Municipal Waste) and Dry Mixed recycling.
- Kites Croft generates additional waste, including cardboard and textiles.


Supporting our customers to safely and securely recycle, recover or repurpose their purchased products is a big step towards lowering our scope three emissions. Looking at our carbon footprint calculations for our 2022 emissions end, the end-of-life treatment of our products contributed towards 15.7% of our total emissions. As our internal Waste Management system continues to strengthen and our Recycling Schemes grow, it will help SMI achieve our scope reduction goals and carbon target to lower our footprint by 45% by 2030.

## **SMI RECYCLING PROCESS**

Our recycling scheme follows the same process as before in many ways, with any changes providing benefits that positively impact the environment.

**Step 1** Order your recycling box via MY-SMI or through our website.



#### Step 3

Once your box is ready for collection, contact your Customer Experience Specialist and we will arrange for DPD to collect it. (We can provide DPD's waste expectation certificate upon request).



Step 5

SMI can provide you with a recycling certificate upon request.



## Step 2 Fill your

Fill your box once your products reach the end of their life. Ensure garments have been washed and are not stained or contaminated. Overfilled or mistaped boxes which lead to the boxes splitting may not be accepted or recycled.



#### Step 4

Bright secure recycling offers a fully sustainable solution, recycling and repurposing 100% of the materials from plastic, textiles and cardboard.



## DO'S AND DON'TS AND ITEMS YOU CAN RECYCLE



#### Don'ts

- Do not overfill the boxes. Any boxes that have split run the risk of becoming contaminated and SMI reserve the right to return or not process these garments for recycling.
- Mix dirty or contaminated products with clean textiles.
- Forget to add your sales order reference number to your recycling box before it's collected!

#### Do's

- Wash your garments before recycling them.
- Separate any dirty or oil stained / chemically contaminated boots, gloves, products etc from the clean items.
- Order one of our SMI recycling boxes!
  Recycling will only be processed if it arrives in our SMI recycling boxes.





### THE FIVE R'S AT SMI

According to the 5 R's there are four actions that should be taken before recycling is considered; refuse, reduce, reuse, and repurpose. Implementing this methodology into our business waste reduction plan will ensure our processes are as efficient as possible, minimising the total amount of waste across our business and helping SMI reach its sustainable goals.

#### REFUSE

Making smarter purchasing decisions, refusing excessive product packaging, and reusing supplier's packaging and boxes, where possible, aligns heavily with our Environmental, Social, Governance strategy. We are working with our stakeholders to minimize what we receive by refusing unnecessary waste were possible. We have also reduced the number of non-recyclable products we purchase from our suppliers, as our eco product range continues to grow, offering our customers a broader recycling scheme trom the purchase to recycling.



#### REDUCE

Reducing the use of wasteful and nonrecyclable products will have a positive impact on a business's ecological footprint. SMI has focused on the most used materials our business has used over the past few years, including single use plastic, plastic packaging, and paper, to see where improvements could be made to reduce our waste. Since 2022, SMI has removed over 4m poly bags, equating 65,000 kg of plastic from our operations.

During 2021 we implemented a paperless warehouse management system at our distribution centre, which has already significantly reduced our paper consumption. Global urgent action is needed to reduce

plastic waste, and SMI have taken several steps to do their bit to combat this issue. These steps include removing plastic bagging from products across orders and using DPD green packing, which is made from 80% reclaimed materials and is 100% recyclable. Another step SMI have taken looks at our offsetting project which is dedicated to cleaning up plastic from the ocean. This project is a commitment to collecting 10kg of plastic for tonne of CO<sub>2</sub> that is offset. SMI offset 434,000kg of carbon which is the equivalent of 217,000kg of plastic collected from the ocean after the emissions is split across the two projects we support.





#### **REUSE**

A 'throw-away' culture in consumer behaviour has led to one of the world's greatest environmental challenges. Single use plastic is an increasing issue, placing more emphasis and priority on reusing products across supply chains and in the workplace. SMI has replaced all single use eating utensils to recycled bamboo or paper alternatives and encourage the reuse of any packaging at our distribution centre.

#### **REPURPOSE**

Repurposing products is commonly known in the green community as upcycling, a popular methoc which can extend a products lifecycle through creativity and innovation. We repurpose cardboard boxes where possible, both at our Head Office for storage and at our Distribution Centre. Suitable returned products are collated, stripped of branding, and repurposed within our local communities as we donate to homeless charities.

#### RECYCLE

Recycling is a commonly used word throughout society, however very few truly understand its meaning and the process behind recycling different materials. Responsible recycling has been a key focus for SMI since we started our sustainable journey. Since launching our textile recycling scheme, we have been exploring different methods we can offer our customers for their remaining uniform and PPE including footwear, safety helmets, gloves, and other plastic related items. Through extensive research we have gained a



deeper understanding of what it truly means to recycle, and truthfully for the time being not all PPE can be 100% recycled. More challenging materials or products cannot be 100% recycled, however there are other ways to prolong a product's life cycle. Products can be donated, repurposed, and converted into Solid Recovered Fuel (SRF) which is energy from waste products. SMI have successfully recovered 370kg of waste, repurposed 3% with the remaining 95% of products being recycled.

Bright Secure Recycling has been a leading innovative recycling specialist since 1998, focusing on universal typical difficult waste to recycle. Adopting a unique business model with a zero to landfill approach and promoting a circular economy turning recycled waste into new market products were possible.

Once your recycling boxes arrive at Bright Secure the materials are shredded or recovered within 24-48 hours. Suitable recycled materials are then carefully crafted into dog friendly products.

## THE **PRODUCTS**







#### Clothing

Bright Secure Recycling have been providing a zero – landfill sustainable recycling solution for the past 24 years. Successfully recycling 1.2 million tonnes of waste and won 26 awards, the wide range of bespoke waste disposal offerings support a number of business as we all take the necessary steps to have a positive impact on the environment.

The majority of your products you will be recycling through our scheme will be processed via closed – loop recycling.

What is Closed-Loop Recycling?

This is the process in which a product is used, recycled and then made into a new product therefore not ending up in landfill.

The significance of this recycling process is the reduced risk to the environment, natural habitat and pollution helping to avoid green house gases which otherwise would be generated from the labour and extraction of materials from virgin resources.

#### **Plastics: How does it work**

The plastic waste is processed with any contaminated material removed. The next step is to shred and granulate the plastic into pellets and then be inputted into the injection moulder machine. This requires 3 key steps before the new recycled product is created.

**Step 1)** Granules are put into the injection moulder

**Step 2)** The injection moulder press melts the granules into a liquified substance.

**Step 3)** Which then travels through pressurised space and it is moulded into the new recycled end product.

Bright Solution Recycling will create a range of products from the plastic including:

- Watering Cans
- House Hold Buckets
- Drink bottles


